### The temporary MVV exemption for Russians no longer applies

Due to changing circumstances, the temporary MVV exemption for people with Russian nationality no longer applies since 2 October 2025. The IND will again assess applications from Russians according to the regular procedures. It remains possible for applicants to be exempted from the MVV requirement on the basis of personal circumstances. The applicant must demonstrate that travelling to their country of origin is not possible or unsafe.

### Reduced salary criterion for highly skilled migrants

Highly skilled migrants must meet the following requirements to be eligible for the reduced salary criterion:

- The highly skilled migrant has or had a residence permit for the search year for highly skilled migrants in the past. Or meets all the conditions for the search year for highly skilled migrants; and
- The residence permit as a highly skilled migrant must have been applied for within 3 years of the graduation date or PhD date. Or within 3 years of the date on which the residence permit for scientific research expired.

When assessing the application, carefully consider whether the highly skilled migrant is eligible for the reduced salary criterion. The 3-year period may not have expired at the time of application.

### New required amounts for highly skilled migrants as of 1 January 2026

The new salary norms for highly skilled migrants were published in the [Dutch Government Gazette](#) on 18 December (in Dutch: Staatscourant). These are the gross standard amounts per month without holiday allowance for 2026:

- Highly skilled migrant aged 30 years or older: €5,942
- Highly skilled migrant under 30 years of age: €4,357
- Highly skilled migrant with reduced salary criterion: €3,122
- European Blue Card: €5,942
- European Blue Card reduced salary criterion: €4,754.

Are you submitting a first-time application or an application for the renewal of a highly skilled migrant residence permit? In that case, the salary of the highly skilled migrant must meet the required amount applicable at the time you submit the application.

**New fees as of 1 January 2026**
