2. Appointment MVV

If the decision is positive, your foster child can make an appointment at a Dutch embassy or consulate in the country of origin. Or in the country where your foster child lives. Is there no Dutch embassy or consulate in the country where your family member lives? Then your foster child can make an appointment in the nearest country. Your foster child will need a valid passport for this appointment. If your foster child does not have a valid passport, in certain cases they can obtain a temporary travel document (laissez passer) from the embassy or consulate. The conditions for obtaining a temporary travel document can be found at netherlandsworldwide.nl.

SUBMITTING DOCUMENTS

Explanation of documents

- The documents are an important part of your application. You can prove that you meet the requirements by submitting documents.
- If you do not submit all documents, the IND's decision will take longer.
- Submit the documents belonging to your application with this appendix. These documents are listed below. You do not need to send the pages with this list with your application.
- For more information about <u>which documents to submit with your application</u>, please see 'Documents' at ind.nl/en/family-reunification.
- Are there any special facts or situations the IND must know about? For example, about your income? Then enclose a letter in which you explain the situation. And (official) documents proving this.

From you

□ Copy of proof of guardianship

A copy of a document showing that you are the guardian of your foster child. This could be a guardianship certificate.

□ Copy of proof of family relationship with foster child

Only if you and your foster child family are related. A copy of documents showing that you are the guardian of your foster child.

From your foster child

□ Copy of proof of identity

For example, a passport or identity card. Or a copy of another document proving the identity of your foster child.

□ Passport photograph

The passport photograph must not be more than 6 months old. It must be clear and sharp.

□ Copy of proof of family relationship with biological parents

A copy of your foster child's birth certificate. You can also send another document showing the family relationship between your foster child and the biological parents, such as a family record book or an excerpt from the civil registry.

☐ Copy of front and back of residence document in case of a country of permanent residence

Does your foster child live in a country that your foster child does not have the nationality of? And is your foster child allowed to live there for more than 3 months (permanent residence)? Then send a copy of the residence permit of the country of permanent residence. Or a document showing that your foster child has applied to be in that country. And is allowed to wait on the decision on this application there.

□ Appendix Antecedents Certificate

If your foster child is 12 years of age or older. This appendix is attached to this application form. Or download the <u>Appendix Antecedents Certificate</u> (PDF, 160 kB) on ind.nl/en/antecedentscertificate.

□ Declaration of civil status

If your foster child is 15 or older, download the <u>Appendix: Declaration of civil status</u> (PDF, 185 kB) on ind.nl/en/marital-status.

□ Appendix Questionnaire family relationship child

If your foster child is 15 or older, download the appendix <u>Questionnaire family</u> relationship child (PDF, 182 kB) on ind.nl/en/questionnaire-child.

From the biological parents

□ Copy of proof of identity

This could be a copy of your passport or identity card. Or a copy of another document proving the identity of the foster child's biological parents. The copy must show the signature.

□ Appendix Declaration of consent

Send along the appendix <u>Declaration of consent of the parent remaining behind</u> (PDF, 149 kB) at ind.nl/declaration-consent. Are you unable to obtain this declaration? Download the appendix <u>Declaration not submitted Declaration of consent of the parent remaining behind</u> (PDF, 145 kB) at ind.nl/en/absence-declaration. And submit it with the application.

□ Copy of death certificate

Has one of the biological parents passed away? Or both parents? If so, please enclose a copy of the death certificate(s).


Pursuant to Articles 3.77, paragraph 11 and 3.86, paragraph 18 of the Aliens Decree, every foreign national aged 12 years or older must complete this appendix.

Please note! This statement consists of 2 pages. You must complete both pages.

1 Declaration of the foreign national

On this form you fill in whether you have ever committed a crime or a criminal offence. These are crimes committed in the Netherlands and criminal offences committed outside the Netherlands. You must answer the questions with **Yes** or **No**. Not completing the form truthfully or failing to report is a criminal offence. This can lead to a sanction. Your answers may have consequences for your application or for a residence permit that you have previously received.

Processing of personal data

The Immigration and Naturalisation Service (IND) processes personal data when it processes your application, notification, or request. This means that if needed the IND will request data from you yourself and other organisations or persons. The IND also uses and stores data and shares them with other organisations. When doing so, the IND strictly adheres to the stipulations of privacy legislation. For instance, the IND must treat data safely and with due care. The law also gives rights. At your request, you are allowed to see which data on you the IND processes. You can also get information on why the IND does so and to whom your data have been passed on.
