#### For whom is this form intended?

You can only use this form if you wish to make an application under the EU Trade Agreement with the United Kingdom (UK) and you are:

- (the client of) a British independent professional; or
- (the client of) a British contractual service supplier.

Do not submit your application until you have fully completed and signed this accompanying form and the application form (GVVA) and collected all the required documents and evidence. If your application is not complete, the IND cannot assess your application correctly.

#### □ Independent professional (GVVA 370)

The independent professional is established in the UK as a self-employed service supplier and has concluded a contract for services for a maximum of 12 months, requiring a temporary presence in the Netherlands. The independent professional supplies services in one of the sectors listed in <u>Annex 22 of the EU-UK Trade and</u> <u>Cooperation Agreement.</u>

The following supporting documents must accompany your application:

- A completed application form for a combined residence and work permit (GVVA).
- Copy or summary of service contract with the client in the Netherlands.
- Copies of diplomas or certificates from university/university of applied sciences. Or you have a diploma/certificate or other evidence that shows that you have an equivalent level of education.
- CV including work experience.
- Proof of the company's registration in the UK.

#### □ Contractual service supplier (GVVA 370)

A UK-based employer employs the contractual service provider. This employer has entered into a contract for services for up to 12 months, requiring the service supplier's temporary presence in the Netherlands. The service provider supplies services in one of the sectors listed in <u>Annex 22 of the EU-UK Trade and</u> <u>Cooperation Agreement</u>.

- A completed <u>application form for a combined residence and work permit (GVVA).</u>
- Copy or summary of service contract with the client in the Netherlands.
- Copies of diplomas or certificates from university/University of applied sciences. Or you have a diploma/certificate or other evidence that shows that you have an equivalent level of education.
- CV including work experience.
- Employment contract with UK employer or transfer letter.
