



Aanvraag om verlening van een terugkeervisum

Application to grant a return visa

Reizen met een terugkeervisum

Het terugkeervisum geeft u in combinatie met een geldig paspoort (of een ander geldig reisdocument) recht op terugkeer naar en toegang tot Nederland. Daarbij mag u op de heen- en terugreis vrij door andere Schengenlanden reizen (transiteren).

Let op! Het terugkeervisum geeft géén recht op verblijf in een ander (Schengen)land voor bijvoorbeeld een vakantie. Wanneer u in een ander (Schengen)land op vakantie wilt, moet u zelf bij het betreffende land informeren naar de toegangs- en verblijfsvoorwaarden.

Traveling with a return visa

The return visa, in combination with a valid passport (or other valid travel document), entitles you to return to and access to the Netherlands. The return visa allows you to transit freely through all Schengen countries on both the outbound and inbound trip.

Please note! The return visa does not entitle you to stay in another (Schengen) country for, for example, a holiday. If you want to go on holiday in another (Schengen) country, you must inquire with the country concerned about the conditions of entry and stay.

Verwerking van persoonsgegevens

Als u dat vraagt, mag u bijvoorbeeld zien welke gegevens de IND over u verwerkt. Ook kunt u informatie krijgen over waarom de IND deze gegevens verwerkt en aan wie deze zijn doorgegeven. Processing of personal data

The Immigration and Naturalisation Service (IND) processes personal data when it processes your application, notification, or request. This means that if needed the IND will request data from you yourself and other organisations or persons. The IND also uses and stores data and shares them with other organisations. When doing so, the IND strictly adheres to the stipulations of privacy legislation. For instance, the IND must treat data safely and with due care. The law also gives rights. At your request, you are allowed to see which data on you the IND processes. You can also get information on why the IND does so and to whom your data have been passed on.
