



Authorisation declaration

With this *Authorisation declaration*, you authorise someone else to act for you. Is that other person your lawyer? Then an authorisation is not necessary.

In section 1 you enter your details.

In section 2 you enter the details of the person you want to authorise.

In section 3 you indicate what the authorised person may do for you.

In section 4 you can read which documents you need to enclose with your *Authorisation Declaration*.

Please note! Complete this authorisation truthfully. Not doing so is a criminal offence. The IND will report this in all cases.

Processing of personal data

The IND records your data in the IND systems to perform legal duties. The IND uses and secures your personal data carefully and based on the requirements of privacy laws. You can read how the IND uses your personal data on ind.nl/en/privacy.

Please attach the following supporting documents to this *Authorisation declaration*:

- A copy of the specific page of your passport or identity card including the identity details.

If your medical situation prevents you from travelling to the IND desk, also include:

- A doctor's note clearly showing that you are unable to travel for a long time, also not accompanied.
- Your valid passport or identity card. *Please note!* The authorised representative must bring your **original** document to the IND desk. A copy is **not** sufficient because a residence endorsement sticker may be placed in your travel document.
